- 6. New Business
  - a. Proposed Budget Review FY 2019 increased Town of Telluride water & sewer rates beginning March 1st. The members agreed to evaluate after the 3<sup>rd</sup> quarter.
  - b. Special assessment for a fire control panel, annunciator, smokes bid from Vyanet It was noted that the 2-28-19 fire inspection the annunciator fire panel were not working. The members agreed to use the capital reserve funds to replace. One bid received by Vynaet second one will be received from Superior alarm (hold).
  - c. Exterior Window washing scheduled for mid-June before Bluegrass
